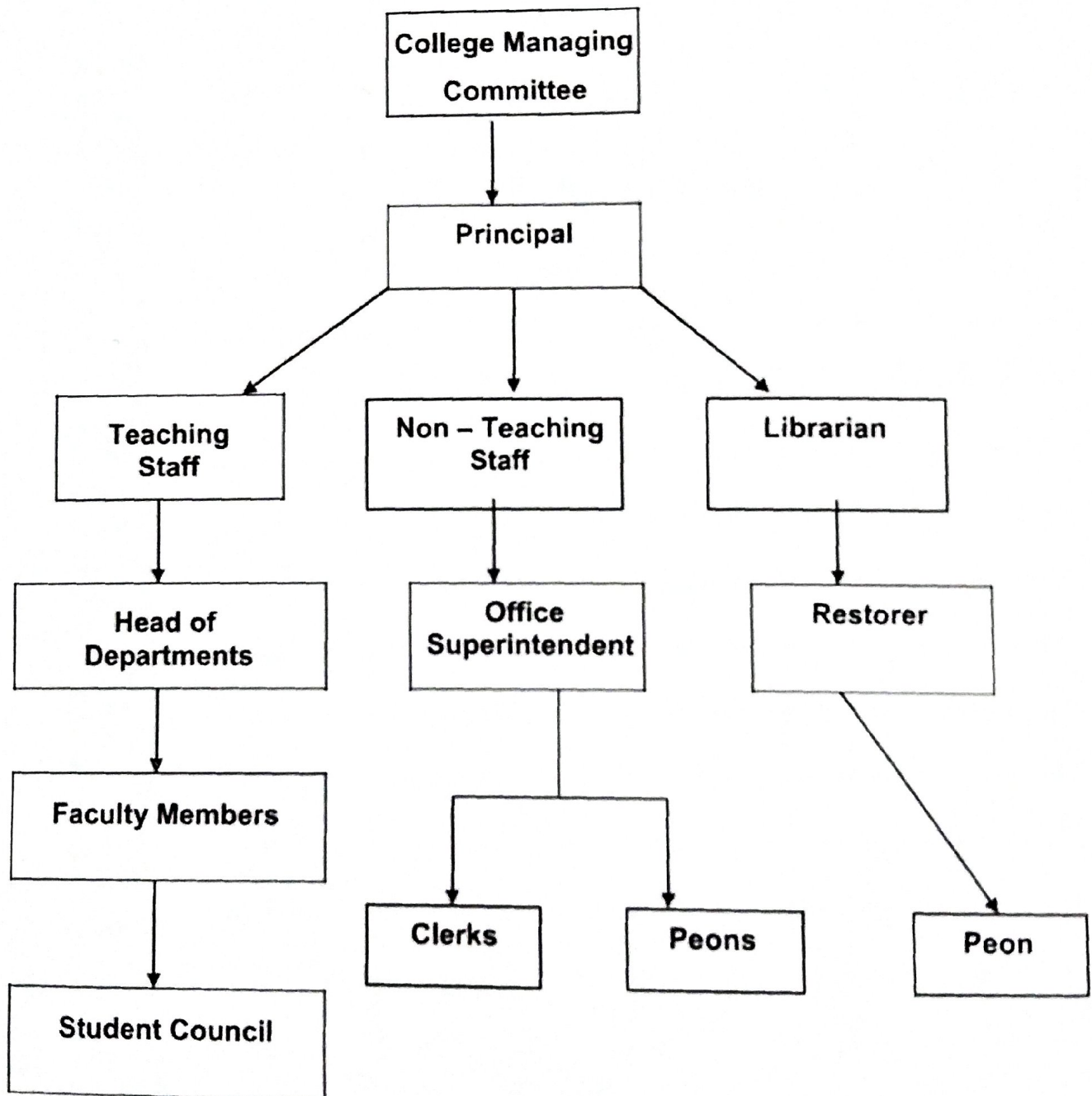



- 1 The minutes of last meeting of the Managing Committee held on 07.03.2019 were read-out and confirmed.
- 2 The Principal apprised the House that a meeting of six Principals of colleges situated in Nawanshahr District was held in R.K.Arya College, Nawanshahr on 04.06.2020 regarding the collection of fees from SC/ST students with effect from the session 2020-21. In that meeting, it was unanimously decided that w.e.f. the session 2020-21, all the colleges of Nawanshahr district will collect required full fee from the S.C/S.T. students i.e. not only from the fresh students but also from the renewal cases. The Managing Committee unanimously confirmed the decision of that meeting held on 4.6.2020. Further letter/Memo No. 22598-607 dated 30.07.2018 of Director, Social Welfare, Punjab was also read-out in the meeting and the Managing Committee unanimously decided to collect the required fee from the SC/ST students.
- 3 Keeping in view the interest of college, the Managing Committee authorized the Principal to take decision as far as any type of fee concession to the students are concerned.
- 4 Due to Covid-19 Pandemic, it was also decided to start on-line teaching as per the directives of Guru Nanak Dev University, Amritsar.
- 5 The Principal thanked Mrs. Nivedita, Co-ordinator (NAAC) and particularly Sh. Lalit Mohan Ji Pathak for his wonderful efforts in assisting the institution during NAAC. The Principal also thanked the Hon'ble President/Secretary, Managing Committee for their co-operation in providing the financial help to the institution regarding NAAC. The House also congratulated the NAAC team of the college.
- 6 Due to Covid-19 Pandemic, the Managing Committee issued verbal directions to the Principal not to make un-necessary appointments of staff during the session 2020-21.

1 Before the start of meeting, Mrs. Taranpreet Kaur, Offg. Principal welcomed Mrs. Neetu Taneja as a new member of the newly constituted Managing Committee of the college.

2 The minutes of last meeting of the Managing Committee, held on 07.03.2020 were read-out and confirmed.

3 Consequent upon the constitution of new Managing Committee of B.L.M. Girls College, Nawanshahr by the Hon'ble President, Arya Vidya Parishad, Punjab (Regd.), Jalandhar vide their letter No. 3899/21 dated 04.03.2021, it was decided that a copy of newly constituted Managing Committee be sent to all concerned banks for information.

4 The Managing Committee of B.L.M. Girls College, Nawanshahr in its meeting held on 15.03.2021 unanimously resolved that the services of Sn. Brahm Parkash, Assistant Professor in Computer Science be regularized in the grade of Rs. 15600-39100+6000 A.G.P. with effect from 30.08.2019 i.e. after the completion of three years of service on dated 29.08.2019 on contract basis on salary of Rs.15600+6000=21600 (consolidated), under the New Grant-in-Aid scheme of Punjab Govt./D.P.I.(Colleges) Punjab notification No. 11/146/13-3Edu.1/248623/5 dated 20.06.2014 (Punjab & Haryana High Court C.W.P.No. 10650 of 2013) and as per letter No.21/05-2018 grant-I(4)/1544 dated 31.08.2020 of Punjab Govt./D.P.I.(Colleges)Punjab, subject to approval of D.P.I.(Colleges) Punjab. The salary/arrears will only be paid after admitting of claims and receipt of grant from the D.P.I.(Colleges) Punjab. This Resolution will be subject to the final out-come of C.W.P. No. 11653 of 2020 and other similar Writ Petitions pending in the Hon'ble High Court or any other decision which may be outcome of any other proceedings arising of the said Writ Petitions or the final orders of Hon'ble Supreme Court of India in the said matter.


