1 Minutes of the last meeting of the Managing Committee, held on 18-07-2022 were read-out and confirmed.

2 In the matter regarding disciplinary proceedings against Sh. Brahm Prakash (under suspension), Asst. Professor-Computer Science, BLM Girls College, Nawanshahr, Inquiry report along with complete record has been submitted by the Inquiry Officer on 03.09.2022 which is placed before the members and taken up for consideration in the presence of members present in the meeting.


The discussion proceeded as under:-

As per the detailed deliberations the members expressed their unanimous concurrence with the findings given in the Inquiry Report holding Sh. Brahm Prakash guilty of gross misconduct on Charges No.1 to 11. The Inquiry Officer has given detailed findings and concluded that not only the delinquent Sh. Brahm Parkash absented from the inquiry proceedings leading to adverse inference, but as per oral and documentary evidence produced by the management, Sh. Brahm Parkash stands proved guilty of Charges No.1-11. Each charge was considered point wise and members are of the unanimous opinion that the inquiry report rightly holds Sh. Brahm Parkash guilty of very serious misconduct and charges No.1-11 stands duly proved as per the Inquiry. In view of above, the members unanimously concur with the Inquiry report and resolve that the copy of Inquiry Report be forwarded to Sh. Brahm Parkash by giving him show cause notice as to why strict action by giving major penalty of dismissal from service be not initiated against him. In this regard, 30 days time be given as per the statutory Rules to represent against the said show cause notice before the Worthy Director (DPI Colleges), Punjab, Mohali.

The effect of above resolution be carried by Sh. Desh Bandhu Bhalla President Managing Committee who is duly authorized to issue the letter/show cause notice in above regard and send the report to DPI Colleges for necessary approval and the University for necessary information.


Since there was no other point, the meeting ended with a vote of thanks to the Chair and Shanti Path.


