GUIDELINES FOR ADMISSION

- * The Principal reserves the right to grant or refuse admission to any student without assigning any reason.
- * Admission to the college is made provisionally at the sole risk and responsibility of a student and is subject to the subsequent approval of G.N.D.U. If approval to the admission is withheld by the competent authority for the reason that the student has failed to provide the required information or documents in time/has hidden some information given false information/ is not eligible to join the class otherwise, the entire responsibility in such a case will lie with the student himself/herself. No claim whatsoever will be admissible in such a case.
- * Admission to different courses is made as per eligibility conditions of G.N.D.U.
- * Candidates whose results are to be declared late can seek admission in the next higher class provisionally subject to the approval of the university.
- * **Candidate having compartment at graduation level shall not be eligible for admission to any Post Graduate Course.**
- * **However students placed under compartment at +2 level can be admitted provisionally to B.A/B.Sc./B.Com/ BCA Ist Sem and UG/PG Diploma Courses subject to university modification with certain conditions.**
- * **Punjab Right to service Act-2011** has been implemented as per notification of the Punjab Govt. bearing letter no. 1/22/2011-2 G.R 2/91591/4 dated 04-09-13 and endorsed by the DPI video memo no. 11/40-2013 A (1) dated 11-12-2013. DOCUMENTS/CERTIFICATES REQUIRED AT THE TIME OF ADMISSION

- a) The Original Certificate of the University/Board examination passed or a certificate informing ward's date of birth and total marks obtained in the latest examination.
- b) Matriculation certificate of date of birth.
- c) A character certificate.
- d) Two passport size photos.
- e) Discharge and migration certificate, eligibility certificate of University in the case of student migrating from the other University or other college affiliated to the same University.
- f) Detail Marks Card and Certificate of +2.
- g) Certificate of Merit for meritorious performance in games and co-curricular activities from the head of institution last attended.
- (h) Student belonging to SC/ST, Backward class must attach required caste certificate with Income certificate issued by the competent authorities along with application to avail benefit of Non payment of non-refundable charges as per Punjab Govt. Instructions. In event of non-production of required documents, students belonging to the relevant category will not be eligible for this exemption.
- (i) Eligibility certificate from G.N.D.U. for the students who have passed their qualifying examination from Institution other than G.N.D.U., Panjab University, Punjabi University or PSEB.
- (j) Students whose result is declared late should submit the Eligibility Certificate within 15 days of the declaration of the result
- (k) Residence Certificate
- (h) Voter Card

Carry on System

Courses having Six Semester Duration

- * A student shall be promoted to third & fifth semester only if he/she has passed 50% paper/courses of the first four semester.
- * A student shall be promoted to VI semester only if he/she has passed all the papers of the first semester.

Note : A student has to study **Five** subjects in all. **Two** are compulsory and **Three** are elective subjects which a student can choose as per her choice and the combinations available in the college.

Sanskrit Scholarship of Rs. 1500/-per annum is given to first 5 students opting Sanskrit.

Every student has to study Environmental studies in IIIrd or IVth Semester as a compulsory subject.

FACULTY OF ECONOMICS AND BUSINESS

B.Sc. (Economics)

B.Sc. Economics is a specially designed programme for those who are keen to become economics specialist. It provides up-to-date knowledge in the field of economics and makes the students skilled, proficient and modern in outlook.

Duration : 6 Semesters

Eligibility : 10+2 examination of P.S.E.B/ any other board recognized by GNDU with at least 40% marks in aggregate in any stream or equivalent examination and Mathematics as one of the subjects.

COURSE STRUCTURE :

All five subjects are compulsory in all the three years

Note : A candidate of B.A.I shall not offer Maths , unless she has qualified the same in her lower class.

TUTORIAL SYSTEM

Each student, is assigned to a tutor who is responsible for her welfare progress. She gives her necessary help guidance in all matters and keeps the guardians/parents regularly informed of her progress and general conduct.

The tutor maintains registers to record day-to-day behaviour of the students in their respective group. This record is used as the basis for certificate to be given to the students on their leaving of the college. The tutors are pleased to interview "the parents or guardian on the matters connected with the welfare of their wards. Meeting of the tutorial group are held once in fortnight, attendance of which is compulsory. Defaulters are fined Rs. 10 per absence. Complicated cases and their solutions are discussed by the tutor with the Principal.

No application will be entertained by the Principal without remarks of the tutor concerned.

The tutor sends reports regularly of every term to the guardians regarding progress and conduct of their wards in addition to examination report.

THE COLLEGE MAGAZINE "SWASTI"

The College Magazine "Swasti" is published every year to provide the students opportunities of self-expression and to develop their literary and journalistic talent.

The Editorial Board of the Magazine consists of the members of the staff and the students. Student editors are selected on merit.

PRIZE DISTRIBUTION FUNCTION

Prize Distribution is held every year in the month of March. It serves as a great impetus for the students. A part from the academic prizes, students are rewarded for winning prizes in games and sports, other curricular and extra curricular activities, good conduct, social service. In the academic field usually the scheme of giving the prize is as follows :-

1. For standing first and second in aggregate in the examination.
2. For standing first and second in individual subject, subject to the condition that one must secure at least 60% marks for the first position and 50% for the second position to become entitled for the prize.
3. It is compulsory to appear and pass in the all subjects to become eligible for academic prize of any category.
4. In the sphere of games prize, college colour , certificate are awarded.

ATTENDANCE

The Principal may drop a student, who is habitually irregular in attendance and is negligent in studies, from the rolls of the college at any time during the term. If a student absents herself from the college for ten or more days continuously without applying for leave, her name may be struck off the college rolls. She may be re-admitted on payment of re-admission fee along with absence fine Rs. 200 per day for all days of her absence. If the name of student is struck off from the college, her lectures shall not be counted till she is re-admitted.

DISCIPLINE

Every student is required during her stay in the college to observe all the rules and regulations of the college laid by the authorities for students. In case of breach of discipline the penalty may take the form of fine etc. according to the seriousness of the fault. Simple living and high thinking continue to be ideals of the institution. They must be modest in dress.

COLLEGE RULES

IDENTITY CUM LIBRARY CARD

All students on the rolls of the college are issued identity cards on joining the college. They are required to keep their identity cards with them during college hours. Book from the library are issued on the production of identity card. This must be produced when demanded to be checked by an official of the college. Any student who fails to produce identity card on demand may be penalised. The identity card is non-transferable. The students should read the rules mentioned in the identity card and adhere to them.

MORNING ASSEMBLY AND WEARING OF UNIFORM

Monday morning assembly is a regular and important feature of college. It is compulsory for all students to come in white Salwar, white shirt, white Dupatta (Black Sweater in Winters). Students coming late and students not in proper Uniform will be fined.

CONDOING OF LECTURES

* Students should be regular in attending classes. If a student falls short of attendance, she cannot sit for the University Examination.

* Deficiency of not more than 10 attendances per subject (theory) and per subject (practical) may be condoned by the Principal. Deficiency of more than 10 but not exceeding 20 per subject (theory) and 10 per subject (practical) may be condoned by the Principal on the recommendation of Lecture Shortage committee on sufficient grounds.

Note : Since University does not permit regular student to be converted into private candidates a student may lose one year if he/she falls short of lectures or fails to fulfill eligibility conditions of the house test.

COUNTING OF LECTURES

The counting of lecture shall be from the date of first lecture delivered. Cases of change of subject and late admission will not be entertained in any circumstances.

The lectures in theory, Practical, Text and composition will be counted separately.

LEAVE RULES

1. Students are required to apply for leave on printed form available from the college office.
2. All applications for leave must be attested by the guardian/parents of the students.
3. Leave for absence must be obtained before the student absents herself.
4. In case of illness, or in special emergency case, application for leave must be submitted within three days of the student's return to the college and the application in such case should be accompanied by necessary documents.
5. Leave up to three days is granted by Tutor of the applicant ; Leave for more than 3 days is granted by the Principal on the recommendation of the Tutor. A Medical Certificate should be attached with the application, in case of illness.
6. Leave of absence from any particular lecture may be given by the lecturer concerned.

CAUTION

If a student does not clear the conditions laid down by the University for appearing in the final examination on the basis of house examination/attendance, she is liable to lose a year, she cannot appear in the capacity of a private candidate without special permission.

RULES FOR WITHDRAWAL

1. A student who wants to withdraw herself from college can do so formally in writing. All such applications must be accompanied by letter from the father or guardian of the applicant.
2. The student shall be liable to pay all the college dues until her name is formally withdrawn.
3. Dues paid for term at the time of admission are not refundable.

EXAMINATION

To assess the progress of the students, Mid Semester Test (MSTs) are held during the year.

MSTs will be held as under : (i) Sept/October (ii) March/April

HOUSE EXAMINATION

- i) A student absenting herself from the examination shall be fined Rs.100 per paper and also detained from taking university examination.
- ii) In case of illness, leave application along with medical certificate should be submitted to the Principal immediately. Or within three days after the exams are over. No leave application will be entertained thereafter.
- iii) Absence or leave from an examination for whatever reason, means nil result or may lead to detention.
- iv) The Principal may at her discretion hold a special test for those who fail to fulfill the conditions prescribed by the University for University Examination.

Eligibility Conditions for Appearing in the University Examination

The students are required to fulfill the following eligibility condition for appearing in the final exams as per GNDU Rules.

- a) She should be on the rolls of the college throughout the academic year preceding the examination.
- b) 25% marks in aggregate of all the subjects or 35% marks in each subject in the House Examination.
- c) 75% attendance of total lectures delivered in each subject, including theory and practical.

Library

Library forms an integral part of any educational institution and the college provides one with a vast collection of books e-books & e-journal. The books in the library do not deal only with the curriculum and subject of syllabus but also with the subjects of mental growth of students as well and hence widen their horizon. Various magazines, journals and dailies are being subscribed. A "Book Bank" is being run since 1977 to cater to the needs of poor, deserving and brilliant students. Beneficiaries from the project are carefully selected by a committee appointed by the Principal.



Library Rules

1. The students will be responsible for the custody of Identity card. Loss of Identity card should be immediately reported to the librarian in case Identity card is lost, a duplicate may be issued on payment of Rs. 50/-
2. The students may take books for 14 days. They have to return them on 14th day or the next day if the 14th is holiday. A fine of 2/-per day per volume will be charged for all books overdue.
3. The books of the following description shall not be issued :
 - a) Reference Books
 - b) Current issues of Periodicals
 - c) Other books specially reserved
4. The books borrowed from the Library must not be transferred to other persons.
5. Any persons who loses books or defaces a book shall be liable to pay double the cost. In case of it being one of the series; the cost of replacement of the whole set of series will have to be paid. Reference books should after consultation be placed back at their proper places.
6. Silence and order must be maintained in the Library. Students are required to be courteous to the Library Staff. The case of infringement of the rules shall be dealt with seriously.
7. A book on return may be renewed further for 3 times only if it is not reserved by any other student.
8. Books can be issued during examination at refundable security basis. Security amount will be equal to the cost

book.

9. The borrower's card is not transferable and should be preserved. In case it is lost, the borrower will be held responsible for the books issued on the card.
10. Attendance of two periods in a week in the Reading Room is Compulsory for the students.
11. Any case not covered by the above rules will be decided by the Incharge of the Library. She may enforce new rules or amend the existing ones in consultation with Library Committee.

CODE OF CONDUCT
