# ACTION TAKEN REPORT FEEDBACK COLLECTED

#### 2018-19

Feedback was received from Students, Alumni. Teachers and Parents in 2018-2019 on an Annual Basis. It was analyzed as presented in the Analysis Reports. Based on the Action Plan mentioned in the analysis report pertaining to students, alumni, teachers and parents a committee was formed to execute the desired Action Plan at the earliest. The committee comprised of the Principal as the Chairperson and five senior faculty members. Based on the Action Plan, an agenda was framed and forwarded to the management. Prompt action was taken to implement the suggestions on the basis of priority. The action taken was then discussed in the board meeting comprising a managing committee, Principal and Staff Representatives.

#### Following actions were taken:

- Diploma in Computer Application (DCA) was started to equip our students for employment.
